# The Ten Mantras of Vimukti

As we come to the end of another eventful year, we refresh our commitment to the ten guiding principles of Vimukti.

- Mantra 1: Free Education**  
Free tuition, books, uniform, winter clothing, and shoes.
- Mantra 2: Short School Days and Long School Year**  
278 school days as opposed to a norm of 200, enabling girls to work part-time and fulfill responsibilities at home.
- Mantra 3: Safe Campus and Transportation**  
Largely all-female campus with safe and time saving transportation by school bus.
- Mantra 4: Nutrition, Health and Hygiene**  
Includes daily nutritious snack in school, annual health check-ups and feminine hygiene products.
- Mantra 5: English Curriculum**  
Increased language proficiency for better performance in School Board exams, and competitive advantage for better paying job.
- Mantra 6: Quality Education**  
Emphasis on low teacher-student ratio, smart class technology, digital learning through personal tablets, regular teacher training, school library, and extracurricular activities.
- Mantra 7: Performance Incentives**  
Annual studentships linked to performance deposited into accounts to be cashed upon completion of School (Class 12). Merit based cash awards for Science, Math, and English.
- Mantra 8: Science, Math and Technology Streams**  
For girls aspiring for professional careers (In Process).
- Mantra 9: Vocational and College Scholarships, and Career Counseling**  
For acquiring vocational skills and/or college degree, and job placements.
- Mantra 10: Community Outreach**  
To foster family support for the girls' careers and to delay marriage.
